4a (Code:) (Expenses \$ 167,004 including grants of\$) (Revenue \$ 5,111) AoH completed its 11th year of serving survivors of suicide loss. It hosts an online forum that operates like a 24/7 support group for over 17,000 loss survivors. The forum is supervised by a mental health counselor and a trained team of 50 survivor moderators and stewards. The forum transcends time and distance, reaching those with little to no other help. AoH also hosts an informational website for survivors and the professionals who serve them. It's website, blog and monthly newsletter contain vital information and resources to help those dealing with the traumatic and complex aftermath of suicide.

4b (Code:) (Expenses \$ including grants of\$) (Revenue \$) (cont.from above) AoH also provides individual grief consultations via Zoom and responds to hundreds of inquiries & requests from those seeking help. In 2019, AoH exhibited at the American Association of Suicidology Conference and the International Funeral Directors Conference. AoH distributed thousands of brochures to suicide loss clients. AoH trained 100 students at Worsham Mortuary College and distributed thousands of brochures to new survivors via funeral directors and first responders. AoH was featured in the N.Y. Times & Wall Street Journal. AoH Founder Ronnie Susan Walker received the Charles Rubey achievement award from Catholic Charities LOSS Program & gave the keynote address to 1000 loss survivors at their Blossoms of Hope event in Chicago.
