4a (Code:) (Expenses \$ 168,608 including grants of\$) (Revenue \$ 15,010) AoH completed its 12th & busiest year of serving survivors of suicide loss. The COVID pandemic resulted in more people reaching out for support than ever before. Our online forum, which operates like a 24/7 support group, hosted more than 19,000 suicide loss survivors. The forum is supervised by a mental health counselor & a trained team of 50 survivor moderators and stewards. Our forum transcends time & distance, reaching those with little or no other help. AoH hosts an informational website for loss survivors and the professionals who serve them. More than 500 people visit our site each day seeking information and support after a suicide. Our website, blog and monthly newsletter contain vital information & resources to help those dealing with the traumatic & complex aftermath of suicide. (continued below)

4b (Code:) (Expenses \$ including grants of\$) (Revenue \$) (cont. from above) AoH provides individual grief consultations via Zoom and responds to hundreds of inquiries & requests from those seeking help. In 2020, AoH had a 300% increase in the number of grief consultations provided. AoH launched a pilot program to support grieving dads. The 8 week closed Zoom group was well received and will serve as a prototype for expansion & scaling of services to specialized groups in the coming year. In 2020, AoH distributed thousands of brochures to new survivors via funeral directors, first responders & suicide prevention advocates. AoH ran a social media public awareness campaign. AoH Founder Ronnie Susan Walker was honored by the American Association of Suicidology for her pioneering efforts & extraordinary service. (continued below)
